053/25 TO RECEIVE THE ANNUAL REPORT OF THE CURRENT CHAIRMAN OF THE PARISH COUNCIL - COUNCILLOR CHRISTINE FEE

'Looking back over the last year we continued with the tidying up theme around the village. For example, clearing back vegetation at the top of Hillside, keeping verges strimmed, tidied up overgrown allotment plots, tidied the Little Orchard, planted more Daffodils at the Old Allotments, installing a new notice board at The Green together with some new planters. Installing picnic benches at the recreation ground, which I am delighted to say were being used soon after they were in place.

As it was such a wet Spring we asked our grass cutting contractor to cut weekly rather than fortnightly, which made a real difference to the grass areas around the village.

The History Society had mentioned in the past that there were some servicemen's name missing off the Roll of Honour at the War Memorial, so this year we were able to have these names engraved, just in time for Remembrance Day.

All this seems to have paid off as Cheddington won the DeFraine cup in the Best Kept Village competition, not only that, as Cheddington scored the most points we were awarded the Sword of Excellence, something this village has never achieved before.

The presentation afternoon was especially nice as one of the judges Bill Chapple, was retiring, so the BKV committee gave a few of its own speeches at afternoon tea in the Chapel. The BKV, I am sure, would not have been won if it wasn't for all the hard work done by our Handyfolk, Keith and Lucy. Although we may smile when we see Keith painstakingly brushing moss off the cobbled area at Gooseacre, this and all the other seemingly "little" jobs make a huge difference. I think we are lucky to have two people who take such a pride in the village.

I would also like to thank Mary for her work in maintaining the flower border at the Memorial and the allotment working group for all its work in keeping the plots looking cared for.

The one big grumble this year was the street lights, they have been off and on more times than the proverbial (am I allowed to say that), allegedly caused by power surges, but this resulted in our contractor almost running out of replacement bulbs, so we have now embarked on a programme of phasing out the old fluorescent lamps and replacing with LEDs, which, I am assured, have built in surge protectors.

In conclusion I would like to thank my fellow Councillors for their support and also for signing up for another four years as we were returned unopposed at last week's election. Thanks to Tony Daly who stood down after six years on the Parish Council and I would also like us to remember with fondness Cllr David Finch who we lost so unexpectedly last October. We welcomed Cllr David Nabbs and Cllr Matthew Kehoe in December, Matthew being the youngest ever member of CPC, although I am sure he is fed up of hearing that now. And very recently Lorraine Firmin who we welcome to her first meeting today.

Thank you to our Buckinghamshire Councillors Chris Poll and Peter Brazier who were also re-elected last week and to Derek Town for his past years as a Buckinghamshire Councillor.

And to our Clerk, Roz who undertakes a vast variety of administrative duties and also practical work around the village, especially in the upkeep of the Pavilion. As the Auditor now requires an "income / expenditure" finance system rather than a "payments / receipts"

Peter and I are both pleased to have been re-elected to Buckinghamshire Council for the Ivinghoe ward.

You now have 2-member representation at Buckinghamshire Council, and I would like to pay tribute to Derek Town who stood down after 10 years' service at both AVDC and Buckinghamshire Council. Derek served you well and at one point was my go-to when I needed cover for absentee members at meetings. Particularly with his role on the planning committee his experience will be missed, and we wish him well on his retirement from his local government role. With Peter and I having served the previous 4 years, we are well versed in the current issues and challenges and will continue to work tirelessly on behalf of all residents. Our good relationship with all 7 parish councils will continue and we will undertake again to attend all Parish Council meetings over the term. This amounts to nearly 100 per year.

As I write this the council is under "no overall control", we both await which party or group will be taking charge of the executive. The outgoing administration undertook to further reduce costs not only by the reduction of member numbers but also reducing Councillor allowances by at least 10% across the board and in some cases more than this. Staff pay has been increased by more than inflation for the lower pay bands. These pay awards are always conducted with staff union representation and over my time on AVDC and now BC, relationships have been good. Finances remain under strain, partly due to the Chancellor's decision to raise NI which has an impact on an employer like BC.

Nonetheless, we await to see what the new administration will bring and in the meantime our ward work will be unaffected. If you need to get in touch, we attend every parish council meeting across the ward, or you can of course email.

058/25 PUBLIC FORUM

Increase of HGVS High Street, Cheddington

Several residents, who were in attendance, were very concerned at the increase in HGVs using the village High Street and Station Road as a 'rat run' despite the introduction of the Freight Zone. Cllr Hollett stressed again that the Freight Zone Strategy could not be enforced. This was the main issue which the residents agreed with.

The main issues/concerns raised in respect of the HGVs were danger to schoolchildren, the noise and vibration caused resulting in potholes/damage to the recently resurfaced High Street and cracks in the houses. The incursion onto the public footpath/damage to the road verge, when lorries try to turn at the Marsworth/Pitstone Road, was also highlighted.

Resident had contacted the Freight Strategy Team and in light of the response he received he suggested that the Parish Council request an open meeting with the officers of the Highway Authority when the Automatic Number Plate Recognition surveys, recently carried out by Buckinghamshire Council, were available. Clerk would contact Graham Hillary.

Janet Roffe – Asked for permission to erect a Bowls Club Sign at the entrance to the Recreation Ground. Her husband, a founder member of the Bowls Club, would donate the funds to do this. *See Minute No 063/25 – Chris Yates 22.04.25.*

Instead, it would investigate a larger, double-sided sign (so it could be seen on the approach to the Rec from both ends of the village) replacing the small burgundy coloured one. It was also proposed that a directional signpost be installed as you enter the car park. Clerk to get costings.

8.04.25 - Tim Hamper, Resident – email - Survey - Field Bordering Manor Pound Road and Leeches Way – Clerk responded, and response acknowledged.

28.04.25 - Chris Joyce, Cheddington Allotments – email - Bark chippings and shelving for excess produce request – Clerk contacted usual contractor regarding supply of bark chippings.
